

Privacy Policy Users

This Privacy Policy (the “Privacy Policy”) governs the way Wunderchef Sverige AB with Organization Number 559060-8534 (“Wunderchef”) uses your personal information (“Personal Information”) when you access the web application or services provided by Wunderchef (the “Wunderchef Services”). All Personal Information that Wunderchef collects in relation to your use of the Wunderchef Services will be processed by Wunderchef in accordance with the Swedish Personal Data Act (Sw. Personuppgiftslagen (1998:204)).

Scope and Application

This Privacy Policy applies to any person that uses the Wunderchef Services.

Collection and storage of personal information

Wunderchef collects Personal Information you provide directly to us, such as when you create or modify your account, request on-demand services, contact customer support, or otherwise communicate with us. Personal Information includes your first and last name, e-mail, telephone number, city, postcode, payment method and any other information that you choose to submit.

When you use the Wunderchef Services Wunderchef can collect the following Personal Information:

- If you permit the Wunderchef Services to access location services through the permission system used by your mobile operating system, we may also collect the precise location of your device when the Wunderchef Services are running in the foreground or background. We may also derive your approximate location from your IP address;
- transaction details related to your use of the Wunderchef Services, including date and time the service was provided, amount charged and other related transaction details.
- information about how you and site visitors interact with the Wunderchef Services, preferences expressed, and settings chosen. In some cases this is done through the use of cookies and similar technologies that create and maintain unique identifiers;

- when you interact with the Wunderchef Services, we collect server logs, which may include information like device IP address, access dates and times, app features or pages viewed, app crashes and other system activity.

How your personal information is used?

You acknowledge and agree that Wunderchef will collect your Personal Information to:

- Provide, maintain, and improve the Wunderchef Services, including, for example, to facilitate payments, send receipts, provide products and services you request (and send related information), develop new features, provide customer support, develop safety features, authenticate users, and send product updates and administrative messages;
- perform internal operations, including, for example, to prevent fraud and abuse of the Wunderchef Services; to troubleshoot software bugs and operational problems; to conduct data analysis, testing, and research; and to monitor and analyze usage and activity trends;
- send you communications, including estimated time of arrival, information about products, services, promotions, news, and events of Wunderchef;
- personalize and improve the Wunderchef Services, including to provide or recommend features or content;
- enable the communication between you and Wunderchef via e-mail, phone or SMS.
- for marketing purposes and in order to improve the quality of the Wunderchef Services.

You furthermore acknowledge and agree that your Personal Information can be used, disclosed or retained in order to comply with the law, regulation, legal processes or requests from a governing agency.

Location Information

Wunderchef request permission in order to collect your precise location from your device per the permission system used by your mobile operating system. If

you initially permit the collection of this information, you can later disable it by changing the location settings on your mobile device. However, this will limit your ability to use certain features of the Wunderchef Services. Additionally, disabling the collection of precise location from your device will not limit Wunderchef's ability to derive approximate location from your IP address.

Promotional Communications

You may opt out of receiving promotional messages from Wunderchef by following the instructions in those messages. If you opt out, Wunderchef may still send you non-promotional communications, such as those about your account or about Wunderchef Services you have requested.

Changes to the Statement

Wunderchef may change this Privacy Policy from time to time. If Wunderchef makes significant changes in the way your Personal Information is treated, or to this Privacy Policy, Wunderchef will provide you with a notice through the Wunderchef Services or by some other means, such as email. Your continued use of the Wunderchef Services after such notice constitutes your consent to the changes. We encourage you to periodically review this Privacy Policy for the latest information on our privacy practices.
